Seasonal Sailing Membership

Article IV

SECTION 8. Seasonal Sailing Membership shall be granted under the following provisions:

1. Applicants must do the following:
 - Must own or co-own a sailboat that races in an active fleet.
 - Must submit a membership application, written recommendations, and shall pay the normal application fee. The application must be approved by the Board of Directors.
 - Must sail a minimum of 10 races each season.
 - Must serve on the race committee one weekend each season.
2. Seasonal sailing membership shall be set under the following conditions:
 - Limited to 20 members and will not be included in the 550 person club membership total.
 - Persons who have completed or resigned any class of membership after 12/31/09, including a prior sailing membership, are ineligible for seasonal sailing membership.
 - May be granted for no more than a period of four consecutive years to an individual after which time said member must elect junior membership, regular membership, or to otherwise resign.
 - At any time a current seasonal sailing member may elect to become a regular or junior member provided the requirements for those classes of membership are otherwise satisfied.
 - Should a seasonal sailing member elect to become a regular member, then the cumulative paid monthly dues of \$50.00 may be transferred to the prevailing initiation fee for that class.
 - Should a seasonal sailing member elect to become a junior member, then the cumulative paid monthly dues of \$50.00 may be transferred to the prevailing initiation fee for that class. However no discount above the maximum junior member initiation fee will be applied later to the regular membership initiation fee.
 - Should there be a waiting list for regular and junior membership at the time the seasonal sailing member elects to become a junior or regular member, then said member will be placed on the waiting list while receiving privileges of said class.
3. The privileges of seasonal sailing membership are as follows:
 - Will have full membership privileges from May 1st to October 31st of each year except for no pool usage, no family privileges and cannot vote or hold office.
 - Will be able to lease wet and dry slips at the prevailing rates if and when all other regular, probationary, junior, and senior members have been given priority status.
4. The dues and fees of seasonal sailing membership are as follows:
 - Monthly dues and assessments will be \$90.00 for the period of May 1st to October 31st. (Dues-\$50.00, Capital Improvement-\$25.00, Building Fund-\$15.00)
 - Monthly food and beverage minimum spending of \$20.00 for the period May 1st to October 31st.
